Other Useful and Valuable services to our veterans conducted on April 7, 2023 was a computer training class for Windows 10 which was attended by 5 veterans. With a very competent Instructor Mr. Joe Brandt, any veteran who uses a computer should attend computer classes conducted by Mr. Brandt. Our Executive Director has observed and attended Mr. Brandt's IT training classes for several years at the Mastick Senior Center in Alameda, California and speaks very highly of the value of his classes for any veteran who uses a computer. Attending his classes has double the productivity of our Executive Director, and he strongly believes that almost all computer users will gain great value in productivity attending these classes.

The range of topics for IT training is very lengthy, from learning about Windows 10 and 11, and also more productive use of our cell phones and tablets which is very valuable.

Once our IT classes get scheduled in the future, the value to many of our veterans is very high.

Financially, the VSC is living within our budget of \$2500 a month. The biggest expense is our one paid staff which is around \$1600, \$200 for each Manager for traveling expenses, \$300 for website management and communications, and \$200 for printer support (ink and paper). Total April expense was \$2300. We forecast May to be approximately the same.

In terms of fund raising, in late May or June, our E.D. will give his briefing "The United States, China and Taiwan." To date most experts are predicting that China will attack Taiwan. Our E.D. has been a China specialist in the Air Force and DoD since 1972. He disagrees with the Experts and will give a presentation that clearly explains why China has not taken military action against Taiwan. Most useful, attendees will be briefed on the terms and conditions that would cause China to attack Taiwan.
